Positioning Your CAA for Excellence

BALLROOM C

This workshop is presented by the national Community Action Partnership in response to the funding challenges that CAAs will be facing in respect to anticipated budget cuts. Using the Community Action Standards of Excellence as the framework, they will discuss concrete strategies, policies and procedures to help build capacity and excellence in your agency, which is the foundation for seeking new resources.

Hire and Retain the Best Staff

The ability to hire and retain the best staff is a primary goal of all good management. Throughout this course, participants learn how to incorporate education, skills, interests, and experience into a profile that may be used to place applicants and employees into suitable jobs, trainings, and/or educational programs. Managers who feel good about themselves and their contribution to their workplace are more effective interviewers. This PosiPower course, like all our courses, has a self-esteem component because positively-minded managers (PosiManagers) are more likely to take the time and make the effort to ensure that the interview is not just done correctly, but exceptionally.
